- 3. The recipient must be a member in good standing of CEC, and should be an appropriately qualified teacher or related specialist as recognized by state and professional authorities.

This year there will be a monetary stipend for both a Novice and a Master Teacher to be awarded at our NJCEC conference on March 16, 2026 at Ramapo College.

Supportive documentation should focus on the qualities, which contributed to the exemplary performance of this person in the delivery of direct services.
